The City of Sachse does not in any way warrant or recommend the quality of any product or service solicited or sold. Any attempt to make such false representation will be considered a violation of the ordinance, subject to a fine of \$500 per day of violation and/ or revoking of permit.

**It shall be unlawful for any person to distribute handbills or advertisements, to sell or solicit goods or funds without carrying the permit in plain view, clearly displayed and recognizable, while engaged in such soliciting or selling. It shall be unlawful for any person to solicit funds without visibly displaying the permit, or to display a permit issued in the name of another person. Failure to do so, or failure to produce the permit upon request of a Sachse Police Officer is also a violation subject to a fine of \$500 per day of violation and/or revoking of permit.**

SELLING, SOLICITING OR TAKING ORDERS SHALL ONLY OCCUR DURING THE TIME THAT IS ONE-HALF HOUR AFTER SUNRISE AND ONE-HALF HOUR BEFORE SUNSET. THIS PROVISION DOES NOT APPLY WHERE THE SOLICITOR IS ON THE PROPERTY BY EXPRESS, PRIOR INVITATION OF THE OWNER OF THE PROPERTY OR A PERSON RESIDING ON THE PREMISES.

IF A HOME HAS A POSTED SIGN WHICH SAYS "NO SOLICITORS", OR SIMILAR LANGUAGE, THEN NO SOLICITING OR PLACING OF HANDBILLS OR ADVERTISEMENTS IS PERMITTED ON SUCH PREMISES.
