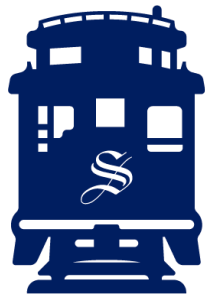

Meeting Minutes
September 22, 2022**

The Board of Directors of the Sachse Economic Development Corporation (EDC) convened in a public meeting at 6:00 p.m. on Thursday, September 22, 2022, notice of the meeting having been posted as prescribed at the Sachse City Hall, 3815 Sachse Road, Building B, Sachse, Texas, as required by Chapter 551, Local Texas Government Code.

Those present: President Tim Shivers; Vice President Marcia Harris-Daniel; Board members Scott McMurdie and Jim Mason; Councilmember Michelle Howarth; Economic Development Manager Jerod Potts; Finance Director David Baldwin; and Assistant Finance Director Ryan Bredehoeft. Richard Chandler arrived at 6:16 p.m.

Those absent: Teddy Kinzer and Mark Potter.

Regular Meeting Opening:

1. Call to Order.

Mr. Shivers called the meeting to order at 6:02 p.m.

2. Invocation and Pledge of Allegiance to the U.S. and Texas Flags.

Ms. Harris-Daniel gave the invocation and led the Board in the pledges.

Public Comment:

Diana Smith, 4802 Sachse Road, President of the Sachse Historical Society addressed the Board. Ms. Smith mentioned the museum is open every Tuesday 9 am to 1 pm, and by appointment. She noted that they would like to build an exhibition hall in their side yard. Ms. Smith mentioned the upcoming Day of the Dead event taking place on October 8 that would include a history-filled hayride through the cemetery.

Consent Agenda:

- 1. Approve the minutes of the August 18, 2022, regular meeting.**
- 2. Accept the monthly revenue and expenditure report for the period ending August 31, 2022.**
- 3. Accept the Quarterly Investment Report for the quarter ending June 30, 2022.**
- 4. Approve the Consent Agenda as presented.**

Ms. Harris-Daniel made a motion to approve all consent agenda items as presented. Mr. McMurdie seconded the motion, and it carried unanimously. Mr. Chandler was not present for this vote.

Regular Agenda Items:

- 1. Receive any reports and presentations by the Sachse Economic Development Corporation President, Board Members, Executive Director, and staff regarding items of community interest, special events, announcements and activities, office, industrial, commercial, retail, business retention, and marketing projects.**

City Secretary, Leah Granger, gave a brief overview of the new public comment process.

Mr. Potts explained that staff has proceeded with the creation of an advertisement to be included in the State of DFW issue of D CEO magazine that will be published in November. He also mentioned that the EDC website redesign project recently held a kick-off meeting, and described the new business guide document currently being developed. Mr. Potts provided the Board with a few important upcoming event dates, and showed the Board the Monthly Development Report compiled monthly by the Development Services department.

Mr. Potts gave a Placer.ai report to the Board, providing in-depth information about visitation during the Red, White and Blue Blast event. Placer.ai is a location-based platform that gives the City foot traffic information. The Board inquired about the number of people visiting restaurants after the event, wondering if this was potentially something that could be marketed. Mr. Potts provided a brief overview of the Void Analysis tool within the Placer.ai software. The Board asked when reports can be pulled from Placer.ai and Mr. Potts mentioned information can be pulled a few days following the date of interest. The Board asked if the data from Placer.ai correlated with any revenue data or credit card transactions. Mr. Potts responded that staff could look in to it.

Mr. Shivers announced he is resigning his position on the EDC Board because he is moving out of Sachse. He noted he has enjoyed his time on the Board, and is proud of the things that have been accomplished. Ms. Harris-Daniel thanked Mr. Shivers for his service.

Ms. Howarth informed the Board that the joint meeting with the EDC and City Council will be held on January 12, 2023.

- 2. Consider authorizing the Sachse Economic Development Corporation to make a donation to Five Loaves Food Pantry supporting the Beacon of Hope program.**

Mr. Potts provided an overview of this agenda item. Though the EDC approved this item on August 18, 2022, 5 Loaves reversed course and would like to apply the funds to the Beacon of Hope program, rather than for the refrigerated box truck. Lon Ricker addressed the Board on behalf of 5 Loaves. Mr. Ricker explained the Beacon of Hope program to the Board, stating Ms. Wallace puts together an individual action plan for each family. Assistance varies from helping people find a job, pay bills, or get their car fixed. The Board asked how the EDC money would be spent, and Mr. Ricker said money will go towards helping people and families as needed. The Board asked how applicants would be vetted. Mr. Ricker

mentioned the money is not going to people directly, but rather 5 Loaves will make payments on behalf of the person getting their car fixed, etc.

Mr. Chandler made a motion to authorize the Sachse Economic Development Corporation to make a donation to Five Loaves Food Pantry supporting the Beacon of Hope program as presented, and Mr. Mason seconded the motion. The final vote was 3-2, with Mr. Shivers voting no, and Mr. McMurdie abstaining because his wife sits on the Board of Directors of Five Loaves. The vote was initially declared to have failed; however, upon further review of the bylaws, a simple majority of the members present constitutes a passing vote. Therefore, this vote did pass and the donation can be made to Five Loaves.

3. Review and discuss the proposed EDC sponsorship policy in addition to discussing EDC support of items related to community relations, sponsorships, and/or advertising.

Mr. Potts brought forward a potential policy for the Board to provide input on, noting this specific agenda item was not an action item. He outlined the process and provided a preliminary amount of \$1,000 that staff would have the ability to approve, subject to meeting the conditions of the guidelines. Requests that meet the guidelines but exceed the \$1,000 threshold would be placed on an EDC Board agenda for consideration, noting however, that requests previously approved during the EDC budget process would not come back to the Board for approval. Mr. Potts gave an overview of the proposed request form and guiding principles, and provided information on historical event sponsorships by the EDC since 2010.

Mr. Chandler commented that if the Board sponsors events, they should fit within the Community Relations line item in the EDC budget. Mr. McMurdie stated he likes the application and thinks the EDC Board did not need to approve individual requests unless there is something that is questionable. Mr. Chandler stated it would speed up the process if the Board specified the events it wanted to participate in each year. Mr. Shivers said the dollar threshold for staff approval should be meaningful, and should not be so low as to never allow staff approval. He also mentioned that those sponsorship opportunities the Board intends to participate in each year should be earmarked. The Board indicated they would like to see a quarterly report from EDC staff about what was given out relative to sponsorships, what was approved, what was denied, and how many requests were received. Ms. Howarth mentioned that having this policy gives staff the authority to say no, whereas right now, there is no policy. Mr. Shivers directed staff to create a framework where there is no approval needed by EDC because recurring and annual giving from the Board is already covered in the budget process. The application process is one that can be handled by staff with reports that are provided to the Board quarterly. Mr. Shivers noted that the budget should include a line item for this program, as well as a line item for the normal recurring items.

There was no action taken on this item.

Mr. Shivers adjourned the meeting to Executive Session at 7:25 p.m.

Mr. Shivers declared the public hearing for Dutch Bros, LLC open at 8:08 p.m.

Matthew Holboke, 5511 Oak Ridge Circle, said the EDC was giving money to Dutch Bros next to a longstanding Sachse business, and asked if money would be given to Bahama Bucks when they go out of business. Mr. Holboke asked what the thought process was.

President Shivers closed the public hearing at 8:10 p.m.

Mr. Chandler mentioned that he made a public statement in regards to the online message board to City Council at their meeting held Monday night.

DRAFT Guiding Principles for Donations and/or Contributions and/or Sponsorships approved by the Sachse Economic Development Corporation Board of Directors

1. Note: these guiding principles refer to requests for funding from the EDC sales tax.
2. Staff must receive a request form for each request, even events occurring annually, unless funding has already been approved as part of the annual EDC Budget.
3. Any request of \$5,000 or more will go to the EDC for consideration.
4. The City Manager or the City Manager’s designee may approve requests under \$5,000 as long as all conditions of the guiding principles are met. That said, at the discretion of staff, some requests may be directed to the EDC for consideration despite being less than \$5,000.
5. Non-profits (501)(c)(3)s or other Internal Revenue Service defined non-profit, educational, or service organizations may be supported. Upon written request from the organization to the EDC or introduced by a Board member, consideration will be given and voted upon for financial support.
6. The monetary support for the organization or organization event must result in the overall benefit of Sachse residents and local businesses.
7. No politically affiliated individual, group, or organization will be considered for donations or financial support.
- ~~8. The entity must be conducting business or activities in and for residents of Sachse, Texas.~~
9. The organization must be in ‘good standing’ with the Internal Revenue Service. The EDC maintains the right to request Year End Reports from the organization at any time.
10. No more than 25% of all revenue generated for the entity may be used for Administrative Costs. The EDC reserves the right to request this information and a formal accounting of it.
11. If a donation, contribution, or sponsorship is provided by the EDC for a specific event, program, service, or cause, and that event, program, service, or caused is canceled, postponed, or otherwise does not occur, the funding must be refunded back to the EDC. At the discretion of the Board and/or staff, the funding can be applied to the same event if postponed to a date specific.
12. If funding is granted, the EDC must be recognized or otherwise promoted for participating in the request.
13. Staff and/or the EDC Board may or may take into consideration whether an organization requesting funding has already received funds from the EDC when deciding whether or not to approve a request.

I acknowledge that I have read and understand the guiding principles for donations and/or Contributions and/or Sponsorships approved by the Sachse Economic Development Corporation Board of Directors. I understand that any request for consideration will be contingent upon meeting the guiding principles.
